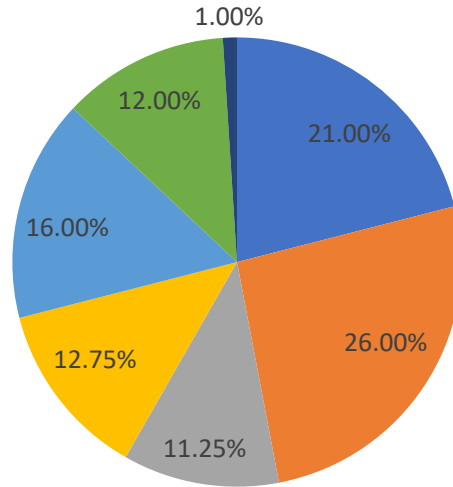

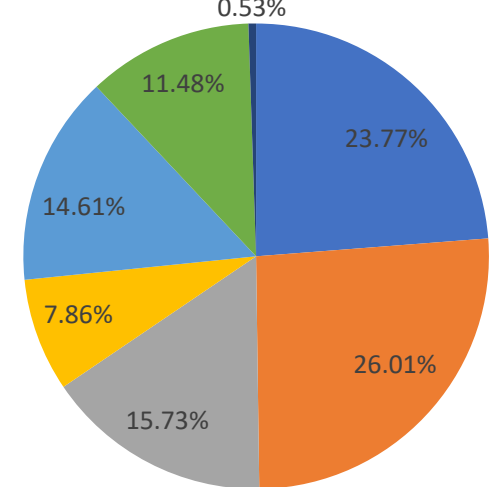

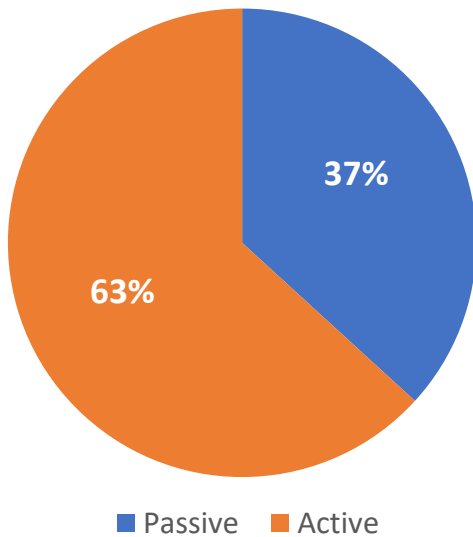


Actual Allocation



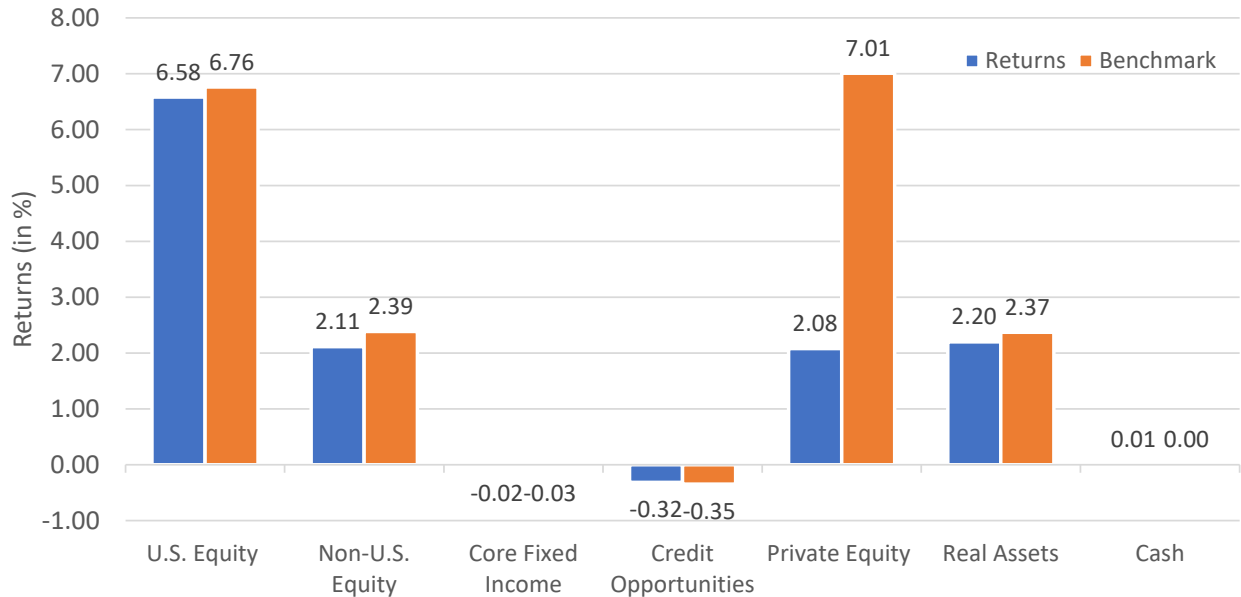

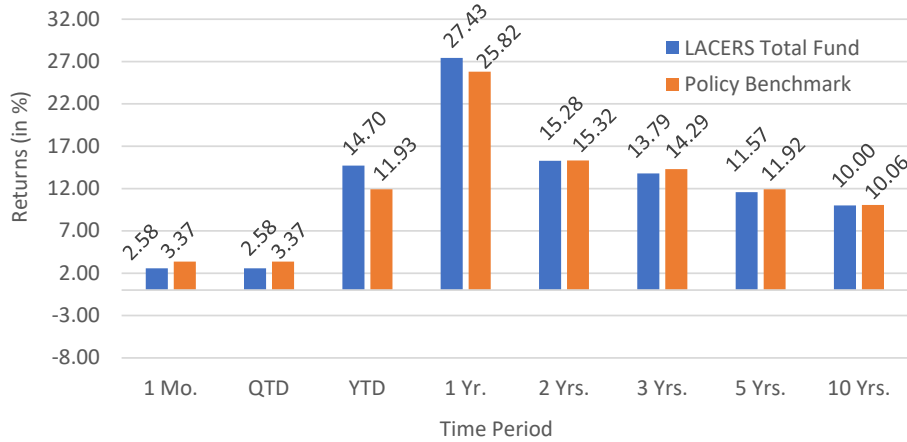
