Recommendation

Executive Summary

This report summarizes LACERS' proxy votes cast for the period of July 1, 2023 to June 30, 2024.

Discussion

Institutional Shareholder Services Inc. (ISS), LACERS' proxy voting agent, voted a total of 12,311 proxy ballots for 10,802 U.S. and non-U.S. company meetings for the period of July 1, 2023 to June 30, 2024. These totals comprise 3,232 ballots for 2,106 U.S. company meetings and 9,079 ballots for 8,696 non-U.S. company meetings.

Staff confirmed that all votes cast were in accordance with the LACERS Proxy Voting Policy. However, 36 proxy ballots (0.29%) were missed for reasons provided in the table below:

Number of Missed Ballots	Explanation
17	Ballots received after cutoff & meeting changes
9	No Power of Attorney (POA) on file at local sub-custodian
3	Voting requirement not met due to nationality
1	Proxy Service not offered
6	Miscellaneous
36	Total missed ballots

Of the 36 total missed ballots, 9 were missed due to POAs not being on file at the local sub-custodians in Brazil and Hungary. Staff has implemented a POA tracking system with Northern Trust, LACERS' custodian bank, in order to reduce the number of missed ballots. This process has led to a 70% drop in missed ballots due to no POAs (from 30 in FY 22-23 to 9 in FY 23-24).
